El. Ed. Part-I Examination for the session 2019-2021, the following modalities for holding the D El Ed Part-I (Theoretical) Examination (Regular/Face to Face) of the Session-2019-2021 are hereby notified:

- The prescribed blank Answer Scripts (Blank Khata) of the Board will be available in the Log-in of the respective Institutes and also in the following two websites of the Board: (1) http://wbbprimaryeducation.org/ & (2) http://www.wbbpe.org/ one day ahead of the 1st day's examination and that should be downloaded and printed for use during the examination each day.
- The students will also be able to download such prescribed blank Answer Scripts by entering the valid Registration No., Roll & Number.
- An examinee shall have to download the blank answer script and print them out. All answers are to be written only on the answer scripts, to be provided by the Board.
- Answers must be precise and to the point. All unnecessary details and irrelevant points shall be counted as discredit.
- For Multiple Choice Type Questions only item numbers of the selected answer should be written without copying the whole statement or part thereof.

- The question papers will be uploaded at 11-50 a.m. sharp on each day in the Log-in of the respective Institutes and also in the following two websites of the Board:

 - 2. http://www.wbbpe.org/
- The students will be able to download the question papers by entering the valid Registration No., Roll & Number.
- ➤ If a student/candidate is unable to download the Answer Script (Blank Khata) or question paper or both, he/she may contact the concerned or the nearest D.El.Ed. Institute by 11.50 a.m. for getting the same downloaded.
- ➤ All the participating D.El.Ed. Institutions are hereby directed to sanitize their institutions and maintain physical distancing norms during the days of the examination.
- ➤ The examinees are requested to upload the scanned copies of their answer scripts at the earliest possible time daily on completion of each examination in the earmarked portal/s in the aforementioned websites, otherwise the system in the said portals in the said websites will be deactivated after a certain period of time.
- ➤ If any candidate/student apprehends that he/she may not be able to upload the answer scripts in an appropriate manner at the earliest possible time on the date of the examination, he/she should approach the head of the D.El.Ed. Institution nearest to his/her home immediately after the end of each examination on the same date of the examination and should submit the original answer scripts to the college authority for uploading the same each day.
- ➤ No uploading of the scanned copies of answer scripts can be done on the next day. No hard copies will ever be received.
- ➤ In case of any difficulty, faced by the candidates/students, the respective Heads of the institutions are requested to extend all kinds of assistance/facilities to them (Examinees), so that they can write their examinations in the institutions and, thereafter, upload their answer scripts in the above noted websites of the Board with the help of the concerned Institutions at the earliest possible time on the same day after the completion of the examination.
- > The same procedure as above, will be followed on all the five days of such examinations.
- ➤ The facility of scribe will provided to the examinees, who are visually challenged or otherwise incapacitated and have lost completely their individual capacity of writing, in accordance with the guidelines/Instructions in the Memo of the Board under No.-355(22)/BPE/D.EI.Ed./2019, Dated- 15/11/2019.
- ➤ Compensatory (Additional) Time will be allowed to such candidates in terms of the guidelines in paragraph-XI of the office memorandum of the Ministry of Social Justice and Empowerment, Department of Disability Affairs, Dated- 26/02/2013.
- ➤ The said notification is attached to this notification and available in the aforementioned websites for ready reference to all concerned.

Sub: Allowance of scribes to the examinees and also extra time for the users of the Scribes/Readers and others with disabilities of 40% and above in Diploma-in-Elementary Education Part-I/II Examinations (Session 2018-2020/2017-2019)

Ref: This office Notification No. 308/BPE/D. El. Ed/2019, Dated 30/09/2019

Sir/Madam.

With reference to the above, I am directed to inform you that the visually challenged and otherwise disabled candidates, who have lost completely their individual capacity of writing, shall be allowed the facility of using scribes from among the persons who are currently students of Class-XI or below.

In such cases you are hereby authorized to allow such facilities of using scribes on proper verification of the documents, mentioned below:

- 1. Admit card
- 2. Valid PH Certificate issued by the competent authority
- 3. Proof/Proofs of having enjoyed such facilities on previous occasion, if any
- 4. The academic standard of the scribe, duly certified by the Head of the Institution where the scribe has been studying

A passport size photograph duly attested by the Head of the Institution shall also be pasted on the certificate

I am further directed to mention below the guideline, contained in Paragraph-XI of the Office Memorandum of the Ministry of Social Justice and Empowerment, Department of Disability Affairs, dated 26.02.2013 for your kind perusal and taking necessary action to ensure smooth conduct of the said examination in the district.

Paragraph-XI: "The word 'extra time or additional time' that is being currently used should be changed to 'compensatory time' and same should not be less than 20 (twenty) minutes per hour of examination for persons who are making use of scribe/reader/lad assistant. All the candidates with disability, not availing the facility of one hour for examination of 3(three) hours duration which could further be increased on case basis". Hope, you will exercise your authority under adequate justification.
